That the Board of Supervisors set a public hearing for June 16, 2015 for 10 minutes to consider and adopt a resolution to establish a parcel fee schedule for the New Cuyama Valley for FY 15/16.

Summary Text:

Each year, your Board adopts a resolution to establish parcel fees assessed to property owners in the New Cuyama Valley to offset the cost for the operation of two transfer stations in this rural community. These parcel fees are developed and approved in accordance with Chapter 17 of the Santa Barbara County Code. A Board Letter will be submitted prior to the departmental hearing providing the proposed fee schedule for these services and will be available to the public on June 11th on the County Clerk of the Board's Website for the June 16th Board of Supervisors hearing and hard copies will be available at the Fifth District office at the Joseph Centeno Administration Building, 511 E. Lakeside Parkway as well as the offices of the Resource Recovery & Waste Management Division at 130 East Victoria Street, Suite 100 in Santa Barbara. Performance Measure: The parcel fees are intended to offset the cost of operating the two remote solid waste transfer stations in the New Cuyama Valley and have not changed since 1992. Public Works has been advised in the past that a change in the parcel fees would require a vote of the community due to Proposition 218.
