Reasons to support exemption findings:

CEQA does not apply to the establishment, modification, structuring, restructuring, or approval of rates, tolls, fares, or other charges by public agencies which the public agency finds are for the purpose of meeting operating expenses, purchasing or leasing of supplies, equipment or material, or obtaining funds for capital projects, necessary to maintain service within existing service areas. The Cuyama Valley is served by two County-operated transfer stations built in 1996, which replaced the local landfills upon their closure. In accordance with Section 25830 of the California Government Code, property owners in the Cuyama Valley pay for solid waste disposal services through parcel fees according to a schedule that was established with the adoption of a resolution by the Board of Supervisors in 1982 (Resolution Number 82-360). The proposed project provides for the establishment of rates (Parcel Fee Schedule) for fiscal year 2015-16 to maintain existing service levels for solid waste collection and for disposal for County facilities serving the Cuyama Valley consistent with the requirements of this statutory exemption. No increase in rates is proposed and no new capital improvements that would expand existing service levels would be funded by the establishment of the rates.
