- b) Determine that these activities are exempt from California Environmental Quality Act review per CEQA Guideline Section 15378(b)(4), since this is a government funding activity that does not involve funding to a specific project that may result in a potentially significant impact on the environment.

Summary Text:

This item is on the agenda to address the newly codified Federal Omni-Circular requirements for current Public Health Department grant award agreements. The Federal Omni-Circular requirements state that the CFDA number and any Single Audit reporting requirements be passed on to subrecipients to ensure that all funded contractors/subcontractors are informed of the corresponding number.

The State is starting to amend all agreements that include federal grant awards to include the CFDA number as a matter of compliance. Because these take the form as formal amendments, the department is requesting that the Public Health Department Director be given authorization to execute these agreements only when the CFDA number is added. The reporting of the CFDA number as a standard contract term is not a new requirement for the States, although it has not been universally done by all State agencies. The grant contract amendments adding the CFDA number is a formality that does not materially change anything related to the scope or amount of the agreement.

Background:

The Federal Omni-Circular process was codified in December 2013 and went into effect in December 2014. This process combined many existing Federal Circulars into one comprehensive document. Concurrently the Federal Omni-Circular revised and updated many of these existing Circulars that included changes to how Federal Grant Awards were to listed and administered. The State and the County are implementing these changes, which include stating CFDA numbers as part of existing and future federal grant awards. These federal grant awards fund services at the Public Health Department and through County community partners. Services provided from this funding include, but are not limited to, health education and risk reduction, non-medical case management, mental health services, community preparedness, response to infectious diseases, laboratory testing, breast cancer screening and referrals, immunization services, and nutrition services.
