Re: Notice of Public Hearing Regarding Proposed Rates and Fees dated April 28, 2015.

I strongly protest against and object to any increase in the Laguna Sanitation District rates or fees.

The following are some of the reasons why:

- 1.The current rates are already excessively high. Most sewer service is about \$20/month. Bakersfield charges \$13.86/month for a single family residence. Visalia charges \$26.45 (\$13.25 for seniors) monthly. Ventura charges \$19.96 bi-monthly. San Luis Obispo is less than \$10/month and Las Vegas is \$60.33 quarterly or \$20.11 monthly. The city of Santa Maria charges \$75 monthly for Trash and Sewer together.
- 2. When the cost of sewer is more than the cost for water, something is drastically wrong.
- 3. For Seniors on fixed or declining incomes, a rate increase is unwelcome and an unneeded hardship.
- 4. With the current water restrictions there will be less sewage and therefore less demand for increased sewage treatment.
- 5. Fees were just raised a little over a year ago.
- 6. The current excessively high fees (2 to 8 times more than that of most cities as cited above) suggest serious problems in the management of the sewer district from possible diversion of funds, to ineptness, fraud, waste and/or abuse. A review by outside experts in sewage treatment should be conducted as well as an independent audit by an outside auditor.

I sincerely hope that the Laguna County Sanitation District will treat the county residents honestly and fairly and reduce rather than increase the fees to be compatible with the reasonable levels of most communities as cited above.
