That the Board of Supervisors:

Option 1:

- A. Take an advocacy position of support, watch, or oppose on SB 788 (McGuire) California Coastal Protection Act of 2015; and
- B. Direct staff to forward, and authorize the Chair to sign a letter stating the Board's decision to the legislative author, members of the legislature including, but not limited to, the county legislative delegation, and appropriate committee chairs; and
- C. Determine pursuant to CEQA Guideline 15378(b)(5) that the above action is not a project subject to CEQA review because it is an administrative activity that will not result in direct or indirect physical changes in the environment.

Option 2:

- A. Take no position on SB 788 (McGuire) California Coastal Protection Act of 2015; and

Summary Text:

This item is on the agenda for the Board of Supervisors to consider taking a position on SB 788 (McGuire) – California Coastal Protection Act of 2015. On June 1, 2015, the Legislative Program

Committee directed staff to bring SB 788 to the Board of Supervisors for consideration and to provide background on the Board's previous support for this issue.

Background:

The California Coastal Protection Act of 2015 would remove an exemption in the California Coastal Sanctuary Act of 1994 that would authorize new oil extraction. In 1994, the California Legislature intended on placing a ban on new offshore oil development with the Sanctuary Act. Included in the legislation is the authorization of the State Lands Commission to enter into a lease for the extraction of oil or gas from state-owned tide and submerged lands in the California Coastal Sanctuary if the commission determines that the oil or gas deposits are being drained by means of producing wells upon adjacent federal lands and the lease is in the best interest of the state. This language creates a loophole that could potentially allow new oil leases.

SB 788 would repeal the loophole language, and thereby ensure a complete ban on new offshore oil and gas leases.

In 2014, the Santa Barbara County Board of Supervisors established precedent by supporting this issue with SB 1096 (Jackson) Marine Protection in the California Coastal Sanctuary Act. The prior legislation is the same policy issue. Furthermore, the legislation is supported under the Community Sustainability principle of the 2015 Legislative Platform.
