Title: ADMHS: 2007-08 Audit Settlement

Budget Action: Increase appropriations of \$1,810,150 in the ADMHS Mental Health Services Fund for Other Charges funded by unanticipated revenue from FY 2007-08 Audit Settlements (\$62,897) and an Operating Transfer from the General Fund (\$1,747,253). Increase appropriations of \$1,747,253 in General County Programs General Fund for an Operating Transfer funded by release of Committed Fund Balance.

Justification: This budget increase is necessary to increase expense appropriations in order for ADMHS to pay the FY 2007-08 Short Doyle/Medi-Cal Final Audit Settlement amount of \$1,810,150 due to the California Department of Health Care Services (DHCS).

This liability is funded by \$62,897 from the positive FY 2007-08 Audit Final Settlement to be paid to the County by DHCS and \$1,747,253 of CEC/MISC allocated and other funds to be released from the Audit Exceptions Committed Fund Balance.
