Title: ADMHS: 2008-09 Audit Settlement

Budget Action: Increase appropriations of \$3,129,620 in the ADMHS Mental Health Fund for Other Charges funded by unanticipated revenue from FY 2008-09 Audit

Settlements (\$112,852) and FY2008-09 Deferred Revenue (\$1,005,628) and an Operating Transfer from the General Fund (\$2,011,140). Increase appropriations of \$2,011,140 in General County Programs General Fund for an Operating Transfer funded by release of Committed Fund Balance.

Justification: This budget increase is necessary to increase expense appropriations in order for ADMHS to pay the FY 2008-09 Short Doyle/Medi-Cal Final Audit Settlem

This budget increase is necessary to increase expense appropriations in order for ADMHS to pay the FY 2008-09 Short Doyle/Medi-Cal Final Audit Settlement amount of \$3,129,620 due to the California Department of Health Care Services (DHCS).

This liability is funded by \$112,852 from the positive FY 2008-09 Audit Final Settlement to be paid to the County by DHCS, \$402,986 of CEC/MISC allocated funds and \$1,608,154 to be released from the Audit Exceptions Committed Fund Balance, and \$1,005,628 ADMHS deferred revenue set aside in prior years for FY 2008-09 EPSDT settlement and FY 2008-09 discontinued MISC claiming.
