Recommended Actions:

That the Board of Supervisors:

- 1. Approve and authorize the County of Santa Barbara Department of Social Services (DSS) Director to execute a Memorandum of Understanding (MOU) with Federal Correctional Complex (FCC) Lompoc, for the provision of DSS Eligibility Worker(s) (EWs) to conduct informational presentations to inmates with an upcoming release date at FCC Lompoc's minimum to low security facilities (Attachment 1); and
- 2. Determine that the approval and execution of the MOU is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15061(b)(3), finding that the execution of the MOU is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment, and where it can be seen with certainty that there is no possibility that the activity may have a significant effect on the environment, the activities are not subject to CEQA.

Summary Text:

This item is on the agenda in order to approve the MOU between DSS and FCC Lompoc for the provision of DSS Eligibility Worker(s) (EWs) to conduct informational presentations to inmates with an

upcoming release date at FCC Lompoc's minimum to low security facilities. Presentations will be conducted at each facility at FCC Lompoc to include: FCC Lompoc-medium security US penitentiary; FCI Lompoc-low security Federal correctional institution; and minimum security satellite camp. Both SEIU 620 and SEIU 721 have reviewed and approved of this MOU since staff participates on a voluntary basis. It is the recommendation of DSS to authorize and execute this MOU with FCC Lompoc.

Background:

FCC Lompoc operates a program for the reentry of released inmates into the community. FCC Lompoc has requested that DSS provide presentations to inmates with an upcoming release date at FCC Lompoc's minimum to low security facilities on information about health care options under the Affordable Care Act and other DSS programs, such as Medi-Cal, General Relief and/or CalFresh. The goal of FCC Lompoc's reentry program is to align comprehensive programs to meet the needs of the inmate population as they prepare to transition to become productive law-abiding citizens.
