ADMHS: 305 CDR #8748 Crisis Stabilization Unit

Budget Action: Increase appropriations of \$357,768 in ADMHS Mental Health Services Act fund for Services and Supplies (\$22,248) and Other Financing Uses (\$335,520) funded by unanticipated revenue from grant funds. Transfer appropriations of \$58,752 in ADMHS Mental Health Services Act fund from Capital Assets to Services and Supplies. Establish appropriations of \$335,520 in General Services Capital Outlay fund for Capital Assets funded by an operating transfer from the Mental Health Services Act

Justification:

ADMHS received a Final Allocation Letter from California Health Facilities Financing Authority (CHFFA) stating the County was awarded \$2.7M for the SB 82 Investment in Mental Health Wellness Grant Program. The grant award provides funding for two capital facilities and service program expansion to increase capacity of the ADMHS' Crisis Service System. This grant will allow Santa Barbara County to rehabilitate and furnish facilities in South County to accommodate a Crisis Stabilization Unit (CSU). The total project costs for alterations of 305 Camino Del Remedio were originally estimated at \$400,000. With the bids for construction now in, the total project budget has now increased to \$459,753. BRR #00004124 will provide \$335,520 to fund the construction portion of the total project, which is inclusive of the low bid and all soft costs, including architectural fees and project management costs. The BRR supersedes BRR#0003912 previously approved by the Board on 5/12 in the amount of \$300,000 which expired at the close of the fiscal year, with \$43,233 expended in FY14-15. Combining the amount expended in FY 14-15 with the proposed BRR # 0003912 results in an estimated project construction cost of \$378,753. The remaining \$81,000 of total project cost consists of includes furniture, fixtures, or equipment paid by ADMHS.

Total grant revenue anticipated in FY 15-16 is \$416,520; of which \$58,752 is already budgeted, resulting in an net increase of \$357,768.
