The Santa Barbara County Board of Supervisors is the responsible agency to transfer funds for transportation projects in all Supervisorial Districts. The County of Santa Barbara has the opportunity to exchange Federal Highway dollars for Non-Federal State Highway Account dollars through an agreement between the State and the County. This exchange gives the County the flexibility to use these funds for a wide range of transportation projects. The Federal mandates associated with Federal funds are not applicable to funds converted to State Highway Account dollars; therefore, these funds can be used without Federal restrictions The re-allocation of funding is not a project by definition. The term project refers to the activity which is being approved and which may be subject to several discretionary approvals by governmental agencies. The term project does not mean each separate governmental approval. The transfer of funds will not result in a potentially significant physical impact on the environment.
