# ZONE 1

#### June 24, 2015

(Based on 2010 Federal Census)

Beginning at the point of intersection of the township line between Townships 7 and 8 North, S.B.B. and M. with the easterly boundary line of the County of Santa Barbara;

- 1. Thence, westerly along said township line, to its intersection with the easterly line of Township 8 North, Range 29 West, <sup>1</sup> S.B.B. and M.;
- 2. Thence, southerly and westerly along the easterly and southerly lines of said township to its intersection with the center line of Happy Canyon Road;
- 3. Thence, northwesterly along the center line of said Happy Canyon Road to and along the center line of Sunset Valley Road (a.k.a. Nira Campground Road) to the junction of Manzana and Davey Brown Creeks;
- 4. Thence, northwesterly along the center line of said Manzana Creek to its junction with the Sisquoc River;
- 5. Thence, northwesterly along the center line of said Sisquoc River to its intersection with the southeasterly line of Rancho Sisquoc;
- 6. Thence, southwesterly along said southeasterly line to its intersection with the center line of Zaca Lake Road:
- 7. Thence, southwesterly along the center line of said Zaca Lake Road to its intersection with the center line of Foxen Canyon Road;
- 8. Thence, southerly along the center line of said Foxen Canyon Road to its intersection with the center line of Zaca Station Road:
- 9. Thence, southerly along the center line of said Zaca Station Road to its intersection with the center line of State Highway No. 154;
- 10. Thence, westerly along the center line of said Highway No. 154 to its intersection with the center line of State Highway U.S. No. 101;
- 11. Thence, southerly along the center line of said Highway No. 101 to its intersection with the center line of Jonata Park Road:
- 12. Thence, southerly along the center line of said Jonata Park Road to the most southerly point in the boundary of the 646.4 acres parcel shown on Parcel Map No. 13895 recorded in Parcel Map Book 46 Pages 90-95 on file in the office of the Santa Barbara County Recorder;

All Section, Township and Range references are to the San Bernardino Meridian (S.B.M.).

- 13. Thence, northwesterly along a private driveway, also being the southwesterly edge of said 646.4 acres parcel, up over the ridge and down to the intersection of said parcel edge with the center line of an unnamed creek;
- 14. Thence, northerly along the centerline of said unnamed creek to the southerly most southeast corner of Rancho La Laguna being a point in the northerly line of Rancho San Carlos de Jonata;
- 15. Thence, westerly along the northerly line of said Rancho San Carlos de Jonata to the southwest corner of Said Rancho La Laguna;
- 16. Thence, northerly along the westerly line of Said Rancho La Laguna to its intersection with the southerly line of Rancho Los Alamos;
- 17. Thence, northwesterly along said southerly line of said Rancho Los Alamos to its intersection with the center line of Santa Rita Road;
- 18. Thence, southerly along said Santa Rita Road center line thru its various courses and trail way to and along its continued portion lying north of Highway No. 246 to its intersection with the center line of Highway No. 246;
- 19. Thence, southeasterly along said Highway No. 246 center line to its intersection with the center line of State Highway U.S. No. 101;
- 20. Thence, southerly along said Highway No. 101 center line to its most southerly intersection with the center line of Gaviota Creek;
- 21. Thence, southerly along the center line of said creek to its intersection with the mean high tide line of the Pacific Ocean;
- 22. Thence, due South to a point on the Santa Barbara County boundary line;
- 23. Thence, in a general easterly direction along said Santa Barbara County line to the southeast corner of said Santa Barbara County;
- 24. Thence, in a general northeasterly and northerly direction along the East line of said Santa Barbara County to the point of beginning and including the islands of San Miguel, Santa Rosa, Santa Cruz and Santa Barbara.

# ZONE 2

#### June 24, 2015

(Based on 2010 Federal Census)

Beginning at the point of intersection of the center line of San Antonio Creek with the mean high tide line of the Pacific Ocean:

- 1. Thence easterly along the center line of said creek to its intersection with West San Antonio Road;
- 2. Thence, northeasterly and easterly along said West San Antonio Road to its intersection with the center line of State Highway No. 1;
- 3. Thence, southeasterly easterly and northeasterly along the center line of said Highway No. 1 to its intersection with the center line of East San Antonio Road;
- 4. Thence, southeasterly easterly southeasterly and northeasterly along the center line of said East San Antonio Road to its intersection with the center line of State Highway No. 135;
- 5. Thence, southeasterly and easterly along the center line of said Highway No. 135 to its intersection with the center line of Santa Rita Road:
- 6. Thence, southerly along the center line of said Santa Rita Road to its intersection with the South line of Rancho Los Alamos;
- 7. Thence, southerly along the center line of said Santa Rita Road thru its various courses and trail way to and along its continued portion lying north of State Highway No. 246 to its intersection with the center line of said Highway No. 246;
- 8. Thence, southeasterly along the center line of said Highway No. 246 to its intersection with the center line of State Highway U.S. No. 101;
- 9. Thence, southerly along the center line of said Highway No. 101 to its most southerly intersection with the center line of Gaviota Creek;
- 10. Thence, southerly along the center line of said creek to its intersection with the mean high tide line of the Pacific Ocean;
- 11. Thence, due South to a point on the Santa Barbara County boundary line;
- 12. Thence, in a general westerly and northerly direction along the boundary line of said County of Santa Barbara to a point due West from the point of beginning;
- 13. Thence, due East to the point of beginning.

### ZONE 3

#### June 24, 2015

(Based on 2010 Federal Census)

Beginning at the point of intersection of the township line between Townships 7 and 8 North, <sup>1</sup>S.B.B. and M. with the easterly boundary line of the County of Santa Barbara;

- 1. Thence, westerly along said township line, to its intersection with the easterly line of Township 8 North, Range 29 West, S.B.B. and M.;
- 2. Thence, southerly and westerly along the easterly and southerly lines of said township to its intersection with the center line of Happy Canyon Road;
- 3. Thence, northwesterly along the center line of said Happy Canyon Road to and along the center line of Sunset Valley Road (a.k.a. Nira Campground Road) to the junction of Manzana and Davey Brown Creeks;
- 4. Thence, northwesterly along the center line of said Manzana Creek to its junction with the Sisquoc River;
- 5. Thence, northwesterly along the center line of said Sisquoc River to its intersection with the southeasterly line of Rancho Sisquoc;
- 6. Thence, southwesterly along said southeasterly line to its intersection with the center line of Zaca Creek;
- 7. Thence, southwesterly along the center line of said Zaca Creek to its intersection with the center line of Foxen Canyon Road;
- 8. Thence, southerly along the center line of said Foxen Canyon Road to its intersection with the center line of Zaca Station Road:
- 9. Thence, southerly along the center line of said Zaca Station Road to its intersection with the center line of State Highway No. 154;
- 10. Thence, westerly along the center line of said Highway No. 154 to its intersection with the center line of State Highway U.S. No. 101;
- 11. Thence, southerly along the center line of said Highway No. 101 to its intersection with the center line of Jonata Park Road;
- 12. Thence, southerly along the center line of said Jonata Park Road to the most southerly point in the boundary of the 646.4 acres parcel shown on Parcel Map No. 13895 recorded in Parcel Map Book 46 Pages 90-95 on file in the office of the Santa Barbara County Recorder;

All Section, Township and Range references are to the San Bernardino Meridian (S.B.M.).

- 13. Thence, northwesterly along a private driveway, also being the southwesterly edge of said 646.4 acres parcel, up over the ridge and down to the intersection of said parcel edge with the center line of an unnamed creek;
- 14. Thence, northerly along the center line of said unnamed creek to the southerly most southeast corner of Rancho La Laguna being a point in the northerly line of Rancho San Carlos de Jonata;
- 15. Thence, westerly along the northerly line of said Rancho San Carlos de Jonata to the southwest corner of Said Rancho La Laguna;
- 16. Thence, northerly along the westerly line of Said Rancho La Laguna to its intersection with the southerly line of Rancho Los Alamos;
- 17. Thence, northwesterly along said southerly line of said Rancho Los Alamos to its intersection with the center line of Santa Rita Road;
- 18. Thence, northerly along the center line of said Santa Rita Road to its intersection with the center line of State Highway No. 135;
- 19. Thence, westerly and northwesterly along the center line of said Highway No. 135 to its intersection with the center line of East San Antonio Road;
- 20. Thence, southwesterly northwesterly westerly and northwesterly along said center line of said East San Antonio Road to its intersection with the center line of State Highway No. 1
- 21. Thence, southwesterly westerly and northwesterly along the center line of said Highway No. 1 to its intersection with the center line of West San Antonio Road;
- 22. Thence, westerly and southwesterly along said West San Antonio Road to its intersection with the center line of San Antonio Creek;
- 23. Thence, westerly along the center line of said San Antonio Creek to its intersection with the mean high tide line of the Pacific Ocean;
- 24. Thence, due West to a point on the Santa Barbara County line;
- 25. Thence, in a general northerly, easterly and southerly direction along the boundary line of the County of Santa Barbara to the point of beginning.
