## COUNTY OF SANTA BARBARA RESOLUTION HONORING CITY OF CARPINTERIA UPON ITS 50TH ANNIVERSARY JUBILEE CALIFORNIA

WHEREAS, the City of Carpinteria incorporated on September 28, 1965 following a special election with 895 votes in favor of cityhood and 635 opposed. It became the 5th city in Santa Barbara County and 306th in the State of California; and

WHEREAS, according to the 2010 census, the population of Carpinteria is 13,044 and its total area is 7 square miles including both land and sea; and

WHEREAS, the City Council consists of five Carpinteria residents and a rotating Mayor selected by the Councilmembers. It utilizes a Council-Manager form of government to carry out the daily operations of the City; and

WHEREAS, since its incorporation, Carpinteria has been able to maintain its small beach town character and charm that includes its recognition as one of the safest and most desirable places to live in California and its recognition as home to "the world's safest beach" and;

WHEREAS, the residents of Carpinteria actively participate in civic engagement, promote the value of stewardship of the environment, and encourage economic development which has produced a high quality of life for its residents and countless visitors; and

WHEREAS, for 50 years the enhanced local control and additional resources that have accompanied cityhood have shaped the city, its amenities and services. Successes include stopping the development of a harbor in what is now the prized Carpinteria Salt Marsh, the preservation of the Carpinteria Bluffs, a state of the art community pool, supporting the vitality of the Carpinteria library and being a key stakeholder in the successful California Avocado Festival now celebrating its 29th anniversary.

NOW, THEREFORE, BE IT AND IT IS HEREBY ORDERED AND RESOLVED that this Board of Supervisors congratulates the City of Carpinteria upon its 50th Anniversary Jubilee and recognizes the valuable contributions that Carpinteria makes to enhance the quality of life for all residents throughout our county and the Tri-Counties region.
