## **Recommended Actions:**

That the Board of Supervisors:

- Receive and file presentation regarding requests and referrals from outside agencies for Public Works to perform work beyond the County's role and maintained transportation system; All Districts (30 Minutes);
- b. Determine that the proposed actions are administrative and other fiscal activities that do not involve commitment to any specific project, and are therefore not a project as defined by State California Environmental Quality Act Guidelines Section 15378; and
- c. Approve and direct staff to file the attached Notice of Exemption.

#### **Summary Text:**

This item is to brief your Board on the emerging issue of California Department of Transportation (Caltrans) and Santa Barbara County Association of Governments (SBCAG) efforts to involve the County in work that has historically been their responsibility. These include items as localized as traffic safety at individual driveways on a State Route, and as regional as design, permitting, financing, and construction of multi-million dollar transportation facilities.

Historically, the County, SBCAG and Caltrans have partnered on issues that affect both state and local facilities, or are regional projects. Recently, these tasks are increasingly directed towards the County to complete, including projects and tasks. These projects do benefit County residents; however, they are entirely outside the County's maintained system. In the last few years, the County has increasingly been

asked to use its resources for regional and state projects. Requests include day-to-day operational work like safety investigations, parking restrictions, and building pedestrian facilities, as well as larger capital projects like the Union Valley Parkway/US101 barrier walls, Carpinteria Avenue to Santa Claus Lane bike path, and San Ysidro/US101 interchange. Although the three agencies strive to work cooperatively to deliver infrastructure projects, the use of County staff and funding for these projects stretches our resources to perform our core mission of taking care of County maintained facilities.

These requests affect the ability of the County to care for its transportation network, given our existing limited resources and diminished State Gas Taxes in the foreseeable future. Limited funding received by the County for its roads are used to operate, maintain, and improve its transportation network, and are not intended for use on other agencies' facilities or to satisfy mandates, conditions and requirements of their projects.

If the trend of increasing requests continues and the County takes on responsibilities of other agencies without additional resources, both staff and financial resources will need to be displaced from other Public Works transportation functions to pursue these projects or additional funding would be required. Priorities would need to be set for work that will not get done to accommodate the new work, or to expand resources to cover the new work. In addition, the County would potentially increase its liability by working on other agency's items.

#### **Background:**

Agencies at the local, regional, and State level are struggling to adjust to increasing needs on their systems with limited resources. At the County, we have responded by reducing and focusing on capital funding to maintain and improve the existing system, limiting taking on new responsibilities such as roadways for new developments, reducing levels of service, and striving to maximize production and efficiency. At the regional and State level, similar efforts are under way, but also include a strategy of utilizing local agencies and community resources where possible, thus reducing the resource demands on themselves. Some examples include:

- Caltrans' State Smart Transportation Initiative (SSTI)<sup>1</sup>, which recommends that "Caltrans should find ways to transfer local-serving roads to local government." Coupled with a recent Caltrans draft District System Management Plan identifying SR192 as a candidate for relinquishment.
- SSTI<sup>1</sup> recommends that when capital construction on a State facility is funded by local agencies, requirements be placed that the local agency fund its maintenance in perpetuity.
- Referrals from Caltrans staff to the County for safety issues, requests for improvements, and general concerns on State Routes, wholly owned and operated by the State, despite a letter from the department requesting that they stop this practice (Attachment A).
- SBCAG staff strategies for development of regional projects by local agencies, such as the UVP barrier walls, the 101 at San Ysidro Interchange, and contributions for design and development of a bike path along US 101 from Santa Claus Lane to Carpinteria Avenue (a requirement of the Caltrans Linden/Casitas Interchange).
- Proposed State Legislation, SB 254, which would streamline relinquishment of state routes to local
  agencies without bringing them up to current local agency design standards, or provide funding to
  maintain the roads.
