




Regional Map






Aerial View



To Santa Barbara County Board of Supervisors:

As a Los Alamos business/homeowner, I would like to add my voice of support to the plans and improvements proposed by the owner of the Skyview Motel. The proposed improvements and wine tasting operation would be a benefit to the community of Los Alamos and the County in the form of increased sales and property tax revenues. The recent newfound interest in local winetasting and associated services, has recently been a boon to struggling local businesses and the community of Los Alamos as a whole.

The only way to accomplish this project is for the County to approve the proposed general plan amendment and rezone from Highway Commercial (C-I) to General Commercial (C-2). This rezone should be approved since the CH Zone is antiquated and has a restrictive list of allowable uses. The County acknowledges this by consistently rezoning CH properties to C-2 in recent community plans, including Eastern Goleta Valley, Santa Ynez, and Los Alamos. This is especially warranted in this case due to the outlying location of the Skyview Motel next to Hwy 101 where any perceived impacts due to noise, traffic, etc. will be much reduced.

Please look favorably upon the investment to improve this corner of the County and the proposed improvements by the owner of the Skyview Motel to help make Los Alamos a more vibrant community.
