Justification: This Budget Revision is necessary to increase appropriations in the amount of \$164,550 in the Public Health Department (PHD) Health Care Fund from supplemental funding received by the Health Resources and Services Administration (HRSA) for Health Center Expanded Services county-wide. These funds will be used to support the salaries and benefits for an additional 4.0 FTE Medical Assistant, 0.50 Public Health Nurse, and 1.0 Staff Nurse to provide enhanced triage, case-management, and other enabling services for PHD Health Center patients.

While the entire grant amount is \$329,100, only \$164,550 is projected to be spent during FY 2015-16 because of the need to attract and recruit the new staff.
