- a) Approve plans and specifications for the Construction of 2015/16 South County Hot Mix Asphalt Overlay; County Project No. S 820667; In the First, Second, and Third Supervisorial Districts, on file in the Public Works Department office;
- b) Award the construction contract in the amount of \$915,814.00 to the lowest responsible bidder, CalPortland Construction, 1625 E. Donovan Road, Santa Maria, CA 93454, subject to the provision of documents and certifications, as set forth in the plans and specifications applicable to the project, as required under California Law;
- c) Approve and authorize the Chair to execute the attached construction contract, which has been reviewed and approved by County Counsel, Auditor-Controller and Risk Manager, or their authorized representatives;

# Summary Text:

On Tuesday, September 15, 2015, three bids were opened for the Construction of 2015/16 South County Hot Mix Asphalt (HMA) Overlay; County Project No. S 820667; In the First, Second, and Third Supervisorial Districts. CalPortland Construction submitted the lowest responsible bid in the amount of \$915,814.00, which is 4.6% below the Engineer's Estimate. The second lowest bid was 2.1% above the Engineer's Estimate.

This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsible bidder. The Department analyzed the bids and determined the low bid is responsive and responsible. Public Works recommends awarding this contract to CalPortland Construction.

# **Background:**

On Tuesday August 11, 2015, one bid was opened for the Construction of 2015/16 Countywide HMA Overlay in the County of Santa Barbara, County Project No. 820667; In all Five Supervisorial Districts. CalPortland Construction Submitted the lowest responsible bid in the amount of \$2,409,087.00 which was 10% above the Engineer's Estimate. This bid was rejected due to cost, and was split into two subsequent, separately bid projects; N 820667 and S 820667; which represent the North and South County streets.

This project will resurface approximately 5.1 lane miles of County maintained roads. Locations are included as Attachment A. Construction will be complete by March 30, 2016. Traffic control will be provided and delays are anticipated to be less than 10 minutes. The Department will notify emergency response services and will use construction area signs to notify the traveling public.

This project will include conventional Hot Mix Asphalt (HMA) paving, as well as a three-phase Stress Absorbing Membrane Interlayer (SAMI) process to resurface the roadway. The SAMI process includes: paving a leveling course to fill in ruts and small holes in the road; applying a SAMI to bridge cracks in the existing pavement; and placing a new asphalt concrete overlay. highly polymerized asphalt emulsion and crushed quality aggregate. SAMI waterproofs the sub base; helps reduce reflective cracking and extends the life of the subsequent overlay.

This is one of many pavement strategies the Department employs in its annual Preventive Maintenance Program and consists of repairing failed areas and replacement of damaged asphalt concrete pavement.
