WHEREAS, California Vehicle Code Section 22507 and the Code of Santa Barbara County, California, Section 23-11, authorize the Board of Supervisors of the County by Resolution, to restrict the stopping, parking, or standing of vehicles, and designate parking restrictions on portions of roads and highways under its jurisdiction; and

WHEREAS, it is in the best interest of public safety that certain portions of County streets or highways in Santa Barbara County be designated with parking restrictions in accordance with said Sections; and

WHEREAS, the parking restrictions imposed by this Resolution shall not be enforceable until signs or markings giving adequate notice thereof have been placed.

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as:

No Stopping, Standing or Parking Zone

- On the north and south side of Exeter Place from the centerline of Cheltenham Road to a point 87 feet east of the centerline of Cheltenham Road.
- On the north side of Exeter Place from a point 170 feet east of the centerline of Cheltenham Road to a point 300 feet east of the centerline of Cheltenham Road.
- On the south side of Exeter Place from a point 420 feet east of the centerline of Cheltenham Road to a point 546 feet east of the centerline of Cheltenham Road.
- On the north side of Exeter Place from a point 486 feet east of the centerline of Cheltenham Road to a point 580 feet east of the centerline of Cheltenham Road

No Stopping, Standing or Parking Zone (7:00 am to 3:00 pm school days)

- On the north side of Dahlia Place from a point 119 feet west of the centerline of Loch Lomond Drive to a point 167 feet west of the centerline of Loch Lomond Drive.
- On the west side of Dickson Drive from the centerline of Winter Road to a point 303 feet north of the centerline of Winter Road.

IT IS FURTHER RESOLVED, that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to designate said locations with appropriate markings and/or signs as time and resources permit.
