All of the Southeast one-quarter of Section 12 of said Township and Range lying southerly of the southerly right of way of the Pacific Coast Railway, EXCEPTING THEREFROM, the Southeast one-quarter of the Southeast one-quarter of said Section 12, also EXCEPTING THEREFROM that portion condemned for public school purposes in the Final Order of Condemnation recorded August 7, 1951 in Book 1008, Page 276, Official Records of said County and State, more particularly described as follows:

- Commencing at the Southeast corner of said Section 12; thence, N00°19'50"E, along the east line of said Section 12, 660.43 feet to the Northeast corner of the Southeast one-quarter of the Southeast one-quarter of the Southeast one-quarter; thence, N89°44'20"W, 25.00 feet to the TRUE POINT OF BEGINNING; thence,
- 1) N89°44'20"W, continuing along the northerly line of the Southeast one-quarter of the Southeast one-quarter, 634.81 feet to an old 4" x 4" stake set at the Northwest corner of said Southeast one-quarter of the Southeast one-quarter of the Southeast one-quarter; thence,
 - 2) S00°22'20"W, along the westerly line of said Southeast one-quarter of the Southeast one-quarter of the Southeast one-quarter 164.00 feet to a ¾" iron pipe; thence,
 - 3) N56°50'40"W, 286.46 feet to a ¾" iron pipe; thence,
 - 4) N44°02'40"W, 260.69 feet to a ¾" iron pipe; thence,
 - 5) N37°31'40"E, 521.68 feet to a ¾" iron pipe set in the southerly line of the present public road; thence,
 - 6) S52°28'20"E along said southerly line, 932.20 feet to a ¾" iron pipe set at an angle point in said public road; thence,
 - 7) S00°19'50"W, 28.79 feet to the point of beginning

TOGETHER WITH all of Section 24 of said Township and Range, EXCEPTING THEREFROM any interest therein conveyed to the Union Oil Company of

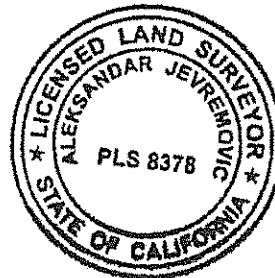
California by Deed dated March 30, 1949, and recorded April 23, 1949, in Book 850 at Page 99 of Official Records of said County and State.

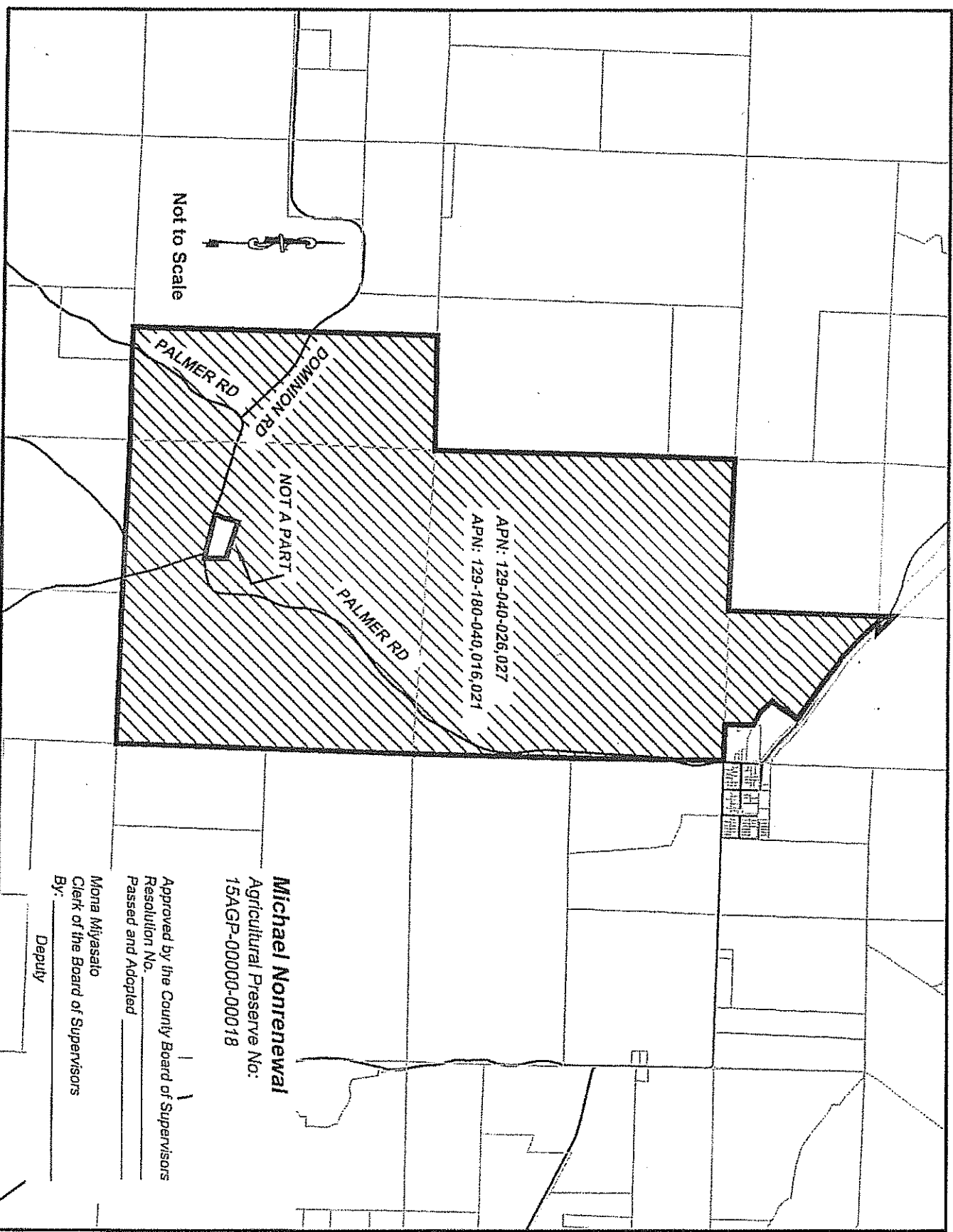
