WHEREAS, Lori Crestfield was born in Los Angeles, California and moved to Santa Barbara in 1981. Having graduated from Agoura High School in 1978, she attended Moorpark College and the University of California at Santa Barbara and earned bachelor's degrees in Developmental Psychology and Sociology in 1983; and

WHEREAS, Officer Crestfield began her career with Santa Barbara County Probation Department as an extra-help Juvenile Institutions Officer in August of 1983, was subsequently hired as a full-time Juvenile Institutions Officer in July of 1984, was promoted to Deputy Probation Officer in 1988, Deputy Probation Officer, Senior in July 2001 and Supervising Probation Officer in August of 2007; and

WHEREAS, Officer Crestfield has held several assignments throughout her career with the Probation Department including the Santa Barbara Juvenile Hall, the Villa Esperanza Counseling and Education Center, Santa Maria and Santa Barbara Adult Supervision, Juvenile Supervision, Investigations, and two tours in the Professional Standards Unit; and

WHEREAS, Officer Crestfield has fond memories of her career, including an assignment with the Problem Enforcement Team at the Santa Barbara Police Department, where she supervised entrenched gang members and rode on patrol with police officers to suppress gang violence in the streets of Santa Barbara, essentially helping to lead the way to a safer community. Lori is proud of her work in the Professional Standards Unit, where she helped bring quality employees and training to the Department. Lori is also proud of being one of the founders of the Liberty Program, a tattoo removal service for former gang members, which allows them to leave their past behind and make a better future for themselves; and

WHEREAS, Officer Crestfield is commended for her faithful and dedicated service to the people who work and live in Santa Barbara County. Her dedication has inspired others be the best they can be. She is looking forward to spending time with her daughter, Lily, her husband, Tony and being more active in Girl Scouts and her daughter's school.
