### TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

This is an amendment (hereafter referred to as the "First Amended Contract") to the Agreement for Services of Independent Contractor, referenced as number <u>BC 15-037</u>, by and between the **County of Santa Barbara** (County) and **Community Health Care Centers of the Central Coast** (Contractor), wherein Contractor agrees to provide and County agrees to accept the services specified herein.

Whereas, this First Amended Contract incorporates the terms and conditions set forth in the and contract approved by the County Board of Supervisors in July 2014, except as modified by this First Amended Contract;

Whereas, County is amending the contract due to an unanticipated change in funding regulation for the State Mental Health Services Act for Prevention and Early Intervention services programs, requiring decreased services and a decrease in the maximum amount of the contract. This amendment decreases funds in the amount of **\$344,893** from the prior Agreement maximum of **\$1,445,654** for a new Agreement maximum of **\$1,100,761** through June 30, 2017.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

- I. Delete <u>Exhibit A1 Statement of Work Mental Health Services in the Primary Care</u> <u>Setting in its entirety.</u>
- II. Delete Page 1 of 3 of <u>Attachment E Program Goals, Outcomes and Measures Mental</u> <u>Health Services in Primary Settings</u>.
- III. Delete Section II, <u>Maximum Agreement Amount</u>, of <u>Exhibit B Financial Provisions</u>, and replace with the following:
  - II. MAXIMUM CONTRACT AMOUNT.

The Maximum Agreement Amount shall not exceed **\$1,100,761**, inclusive of **\$472,374** for FY **14-15**, **\$481,822** for FY 15-16, and **\$146,565** for FY 16-17 and shall consist of County, State, and/or Federal funds as shown in Exhibit B-1. Notwithstanding any other provision of this Agreement, in no event shall County pay Contractor more than this Maximum Agreement Amount for Contractor's performance hereunder without a properly executed amendment.
