CSD - Orcutt Community Play Fields Replacement

Budget Action: Establish appropriations of \$388,000 in the Community Services Department, Parks Division General Fund for Services & Supplies (\$194k) and to increase Committed Parks Projects fund balance (\$194K) funded by unanticipated insurance proceeds and recovery (\$213K), unanticipated reservation fees (\$95K), and a decrease in

appropriations for Salaries and Employee Benefits (\$80K).

Justification:

The renovation of the play fields at Orcutt Community Park involves the removal and replacement of approximately 190,000 square feet of glass-contaminated turf to bring the two play fields back to a safe playing condition. The total renovation costs are estimated at \$388,000. This was an irregular loss, outside the normal scope of recurring park operations. The Department plans to commence this project as soon as it receives poard approval, but the project will likely not be fully completed until the next fiscal year. Unspent project balances will be set aside in the current year and to spent in the next fiscal year.

The Department anticipates at least \$213,000 in insurance proceeds that will be available to the project, and requests to fund the remainder of the project utilizing budgetary savings from salary & benefits and unanticipated reservation revenue in the current year.
