Recommended Actions:

That the Board of Supervisors:

- a) Authorize the Community Services Director or designee to execute Scope of Work Exhibits for the Fiscal Year (FY) 2015 CoC Program Competition—in forms substantially similar to the FY 2014 Scope of Work included as Attachment A--that amend Continuum of Care (CoC) Program Grant Agreements with the U.S. Department of Housing and Urban Development (HUD) and provide funds for the following projects:
 - i) \$21,913 for Good Samaritan Shelter's Clean and Sober Living project;
 - ii) \$104,767 for the County's operation of the Homeless Management Information System (HMIS);
 - iii) \$64,283 for the County's HMIS Expansion I; and
 - iv) \$63,786 for Good Samaritan Shelter's Lompoc Transformative Housing project;
- b) Authorize the Community Services Director or designee to execute the FY 2015 CoC Program Grant Agreement for \$47,323 for Santa Barbara County CoC Planning in a form substantially similar to the FY 2014 grant agreement included as Attachment B;
- c) Approve and authorize the Chair of the Board of Supervisors to execute a CoC Program Subrecipient Agreement with Good Samaritan Shelter for Clean and Sober Living in the amount

of \$21,318 for the period beginning February 1, 2016 and ending January 31, 2017 (Attachment **C**);

- d) Approve and authorize the Chair of the Board of Supervisors to execute a CoC Program Subrecipient Agreement with Good Samaritan Shelter for Lompoc Transformative Housing in the amount of \$61,700 for the period beginning October 1, 2016 and ending September 30, 2017 (Attachment D);
- e) Authorize the Community Services Director or designee to submit project applications and all certifications, standard forms, and other related documents to the Santa Maria/Santa Barbara County CoC and HUD for Clean and Sober Living, HMIS, HMIS Expansion I, Lompoc Transformative Housing, and Santa Barbara County CoC Planning for the FY 2016 CoC Program Competition; and
- Determine that the recommended actions do not constitute projects subject to environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(4), finding that the projects are a creation of government funding mechanisms or other government fiscal activities, which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment, and direct staff to file a Notice of Exemption (Attachment E).

Summary Text:

The U.S. Department of Housing and Urban Development (HUD) competitively awards funds through the Continuum of Care (CoC) Program for the provision of housing and support services to homeless individuals. The Santa Maria/Santa Barbara County CoC, the homelessness assistance planning body for Santa Barbara County, is responsible for the implementation of the CoC Program, although it must designate other entities to carry out certain activities. The County of Santa Barbara (County) serves multiple roles with respect to the local implementation of the CoC Program. As grant administrator, the County administers funds awarded through the CoC Program for Good Samaritan Shelter's Clean and Sober Living and Lompoc Transformative Housing projects, a responsibility the County has had since 2001. As the Homeless Management Information System (HMIS) Lead Agency, the County manages the operations of the county-wide HMIS and applies for funds through the CoC Program to support it. As the Collaborative Applicant, the County performs tasks critical to the local implementation of the CoC Program, such as preparing the Consolidated Application for the annual CoC Program Competition and evaluating outcomes of projects funded through the CoC Program.

The Community Services Department (CSD), on behalf of the County, applies annually to the Santa Maria/Santa Barbara County CoC and HUD for CoC Program funds to support the delivery of transitional housing and permanent supportive housing to homeless and formerly homeless individuals, respectively; the collection of data on individuals assisted by federally-funded homelessness assistance programs; and overall implementation of the CoC Program in Santa Barbara County. In the Fiscal Year (FY) 2015 CoC Program Competition, the County was awarded a total of \$302,072 for five projects: Clean and Sober Living, HMIS, HMIS Expansion I, Lompoc Transformative Housing, and Santa Barbara County CoC Planning. projects. CSD intends to apply for a continuation of funds for the same projects in the FY 2016 CoC Program Competition.

Recommended actions a) and b) allow CSD to accept CoC Program funds awarded to it in the FY 2015 CoC Program Competition. Recommended actions c) and d) facilitate the pass-through of a portion of funds to Good Samaritan Shelter. Recommended action e) authorizes CSD to apply for funds in the FY 2016 CoC Program Competition.

Background:

Authorized by the McKinney-Vento Homeless Assistance Act, as amended by the Homeless Emergency Assistance and Rapid Transition to Housing Act of 2009, the CoC Program is designed to assist homeless individuals and provide them with the services needed to help them move into transitional and permanent housing with the goal of long-term stability. Funds awarded through the CoC Program may be used to pay for the costs of establishing and operating projects under five program components: permanent housing, transitional housing, supportive services only, Homeless Management Information System (HMIS), and for eligible communities, homelessness prevention. Additionally, CoC Program funds may be used to support CoC planning activities, such as evaluating outcomes of projects funded by the CoC Program and monitoring for and enforcing compliance among recipients and subrecipients.

FY 2015 CoC Program Competition Awards

Pursuant to authorization granted by the Board of Supervisors on June 16, 2015, the Community Services Department (CSD) applied for CoC Program funds in the FY 2015 CoC Program Competition for five projects, which are identified in Table 1. CSD was notified of its selection for funding for Clean and Sober Living, Lompoc Transformative Housing, and Santa Barbara County CoC Planning on March 8, 2016 and for HMIS and HMIS Expansion I on May 2, 2016. CSD anticipates that HUD will provide it with grant agreements for the aforementioned projects in June 2016. As HUD requires that CSD execute and return grant agreements within ten days of receipt, CSD is seeking authority from the Board of Supervisors to execute these grant agreements to meet HUD's deadline.

CSD must execute an agreement with HUD for each project in order to access awarded funds. HUD will provide a Scope of Work Exhibit for the FY 2015 CoC Program Competition (Scope of Work) for each renewal project—Clean and Sober Living, HMIS, HMIS Expansion I, and Lompoc Transformative Housing. The Scopes of Work are agreements that function as addenda to the CoC Program Grant Agreements (a sample of which is attached as Attachment F) that serve as the base agreements between HUD and the County for these projects. CSD has not yet received Scopes of Work for each existing renewal project, although it anticipates that the Scopes of Work will be substantially similar to the Scopes of Work for the FY 2014 CoC Program Competition, a sample of which is attached (Attachment A). CSD will return to the Board of Supervisors for authorization to execute the Scopes of Work if they substantively differ from the Scopes of Work for the FY 2014 CoC Program Competition. Agreements for any subsequent renewals of these projects will also be in the form of scopes of work between HUD and CSD.

Santa Barbara County CoC Planning is a non-renewable project. As such, the County, as Collaborative Applicant, applies annually for new funding on behalf of the Santa Maria/Santa Barbara County CoC (Local CoC) to support planning activities related to the CoC Program; the Collaborative Applicant is the only entity allowed to apply for such funding. CSD has not yet received a FY 2015 CoC Program Grant Agreement for Santa Barbara County CoC Planning though it anticipates that the FY 2015 CoC Program Grant Agreement will be substantially similar to the FY 2014 CoC Program Grant Agreement, which is attached (Attachment B). CSD will return to the Board of Supervisors for authorization to execute the FY 2015 CoC Program Grant Agreement if it substantively differs from the FY 2014 CoC Program Grant Agreement.

Subrecipient Agreements with Good Samaritan Shelter

CSD serves as the grant administrator of CoC Program funds awarded for Good Samaritan Shelter's Clean and Sober Living and Lompoc Transformative Housing projects. As administrator, CSD performs grant management and compliance oversight activities, including project monitoring and annual performance reporting. Good Samaritan Shelter, as subrecipient, is responsible for carrying out the projects in accordance with federal requirements and the terms of the CoC Program Subrecipient Agreements.

Clean and Sober Living and Lompoc Transformative Housing provide housing with supportive services to homeless and formerly homeless individuals in northern Santa Barbara County. Housed in two single family residences in the Santa Maria area, Clean and Sober Living is a 16-bed permanent supportive housing project that serves formerly homeless individuals who are disabled and have histories of chronic substance abuse and mental illness. Clean and Sober Living was awarded \$21,913 for the period beginning February 1, 2016 and ending January 31, 2017 and, of that amount, \$595 will be retained by CSD for grant administration and \$21,318 will be passed to Good Samaritan Shelter for project operations. Lompoc Transformative Housing, a 19-bed transitional housing project that serves homeless families, was awarded \$63,786 for the period beginning October 1, 2016 and ending September 30, 2017. Of that amount, \$2,086 will be retained by CSD for grant administration and \$61,700 will be passed to Good Samaritan Shelter for project operations and service provision.

FY 2016 CoC Program Competition

CSD intends to apply in the FY 2016 CoC Program Competition for a continuation of funds for Clean and Sober Living, HMIS, HMIS Expansion I, and Lompoc Transformative Housing. The anticipated request amounts for renewal projects are identified in Table 2. CSD also intends to apply for new funding for Santa Barbara County CoC Planning. CSD intends to apply for the maximum amount of funds permitted by HUD, although HUD has not yet provided information on the amount allowable for Santa Barbara County CoC Planning.

While the FY 2016 CoC Program Notice of Funding Availability has not yet been published, CSD staff anticipates its publication, and therefore the start of the competition, in early summer 2016. CSD staff, with authorization from the Board of Supervisors, will submit applications for the identified projects to the Local CoC and, if approved by the Local CoC, to HUD.

All applications will undergo a two-step review, first at the local level by the Local CoC and second at the national level by HUD. A CoC Review and Rank Committee appointed by the Santa Maria/Santa Barbara County CoC Board to act on behalf of the Local CoC will review and rank or reject applications for projects originating in Santa Barbara County. Ranked applications will be included in the CoC Consolidated Application and Project Priority Listings and submitted to HUD for funding consideration.

CSD will provide an update to the Board of Supervisors should the CoC Review and Rank Committee reject any of its applications.

Performance Measure:

HUD evaluates the performance of CoC Program-funded projects that provide housing and/or services to homeless and formerly homeless individuals according to two measurement areas: housing and income. Clean and Sober Living and Lompoc Transformative Housing are subject to this evaluation and are expected to achieve the measures identified in Table 3 during the projects' operating years.

In addition, Clean and Sober Living and Lompoc Transformative Housing must serve, at a minimum, 16 formerly homeless individuals and six homeless families, respectively, during the projects' operating years.

CSD will monitor each project's performance throughout its operating year using data inputted into HMIS by Good Samaritan Shelter staff.

Narrative:

CSD was awarded a total of \$302,072 in the FY 2014 CoC Program Competition. Of that total, CSD will retain \$219,054 to operate the county-wide HMIS, carry out CoC planning activities, and administer awarded funds. The balance, or \$83,018, will be passed to Good Samaritan Shelter, the subrecipient for Continuum of Care (CoC) Program Fiscal Year 2015 Grant Agreements and Applications for the Fiscal Year 2016 CoC Program Competition

Clean and Sober Living and Lompoc Transformative Housing, to operate the projects and provide client services.

Recipients, or subrecipients, of CoC Program funds must provide cash or in-kind match that is no less than 25 percent of the award amount. Good Samaritan Shelter will provide cash match for Clean and Sober Living and Lompoc Transformative Housing. For HMIS, HMIS Expansion I, and Santa Barbara County CoC Planning, CSD has budgeted \$54,094 in General Fund Contributions to satisfy the match requirement. Funds will be used to support CSD staff costs incurred for HMIS and CoC Planning activities.

Key Contract Risks:

The CoC Program is a federally-funded program subject to associated federal requirements. As the recipient of federal funds, the County is responsible for ensuring that CoC Program funds are used in accordance with CoC Program requirements. CSD has experience administering CoC Program funds and funds awarded under other HUD programs on behalf of the County. Good Samaritan Shelter has prior experience operating federally-funded homelessness assistance projects, including those funded by the CoC Program.

The CoC Program Subrecipient Agreements are cost-reimbursement contracts. This allows CSD to disburse CoC Program funds to Good Samaritan Shelter for eligible incurred costs to the extent prescribed by the CoC Program Subrecipient Agreements. Disbursements will be made after Good Samaritan Shelter demonstrates that reimbursable services were provided and substantiates the eligibility of incurred costs to the satisfaction of CSD.
