That the Board of Supervisors:

Approve and execute the Agreement with Explore Ecology Waste Reduction Education programs for the two-year period of July 1, 2016 through June 30, 2018, in the not-to-exceed amount of \$144,541.

Summary Text:

This item is on the agenda in order to provide high quality Explore Ecology education to students in grades K-12 attending public and private schools, after school programs, and summer camps in county unincorporated areas and in the City of Goleta. Other cities contract for their own education services. It educates and encourages students to reuse, recycle, and/or compost materials through classroom presentations, field trips to its reuse store, Art from Scrap, and a pilot post-consumer food scrap composting program for students in 3rd through 5th grades. It also connects environmental topics, such as natural resource conservation and climate change to the County's waste reduction programs.

Background:

For the last 25 years, Explore Ecology has provided waste reduction education to students in grades K-12 and county residents on the need to reuse materials and to prevent and reduce waste to decrease the amount of materials that are sent to local landfills. Its efforts have helped the County exceed the diversion goals established in Assembly Bill (AB) 939, which required jurisdictions to divert at least 25 percent of their waste by 1995 and at least 50 percent of their waste by 2000 from being sent to a landfill.

Its classroom presentations cover such topics as: reuse, waste prevention and reduction (including hazardous waste), conservation of natural resources, an overview of how landfills are operated, climate change and the greenhouse effect, and composting. Lessons on waste reduction cover concepts of shopping choices and packaging and how decisions made in those areas affect waste generation. Alternatives to disposal of materials that cannot be recycled or composted are discussed, including donating used items to thrift/reuse stores, using durable vs. disposable containers, and shopping with reusable rather than plastic bags. Composting lessons include what compost is, the decomposition cycle, what can be composted, how much food is currently wasted, how composting can help reduce greenhouse gases and the associated effect on climate change, and how compost helps plants.

During the field trips to Art from Scrap, students are shown a wide variety of materials donated by people for reuse rather than being thrown away. Students are also taught the concepts of reduce, reuse, recycle, and compost. Like the classroom presentations, alternatives to waste disposal for materials that cannot be recycled are discussed with an emphasis on reuse and donation.

Through the pilot food scrap composting program at selected schools, Explore Ecology staff will provide lessons on composting and coordinate with school staff to have food scraps collected once per week for composting.

FY 16/17: Provide Waste Reduction Education to 6,400 K-12 students, and implement and manage the School Garden Composting Pilot Program (2,000 K-12th grade students within the South County unincorporated areas and the City of Goleta, as well as students participating in our on-site post-consumer composting pilot program. In North County unincorporated areas, programs will be provided to at least 4,400 K-12th grade students).

FY 17/18: Provide Waste Reduction Education to 6,400 K-12 students, and implement and manage the School Garden Composting Pilot Program (2,000 K-12th grade students within the South County unincorporated areas and the City of Goleta, as well as students participating in our on-site post-consumer composting pilot program. In North County unincorporated areas, programs will be provided to at least 4,400 K-12th grade students).
