Summary Text:

The Agricultural Commissioner/Sealer will present your Board a summary of statistics and trends from information received from our local agricultural industry. The report reflects the production values of our local agricultural industry. The figures provided in the annual production report are gross values and do not represent net profit or loss experienced by individual growers or by the industry as a whole.

These are some highlights of the 2015 Agricultural Production Report:

- a) Production value is \$1,479,092,562.00. This is a .7% decrease from 2014
- b) Strawberries our #1 commodity again, but was down 26 million dollars from 2014
- c) Wine grapes dropped from #2 commodity to #3 this year. A loss of value of 49 million dollars compared to 2014.

The Annual County Production Report is prepared every year by the Agricultural Commissioner as it is required by the California Food and Agricultural Code section 2279. The Annual County Production Report contains valuable information and is an important tool for growers, insurance industry, banking industry, marketers, government and all those who make decisions about agriculture in our county.
