Budget Action: Decrease budgeted revenues of \$735,780 in multiple departments and funds in Property Tax Revenue funded by release of Nonspendable Fund Balance

established by impounded revenues due to assessment appeals filed by taxpayers.

Justification: Previously under previous Board Authorizations (File # 12-00470 6/19/2012; #14-00281 4/15/2014; #15-00469 6/2/2015) the Auditor-Controller impounded selected 2011-12, 2013-14 & 2014-15 disputed property taxes. When impounded, property taxes are recognized as receivables and due to the unspendable

nature of receivables, nonspendable fund balance was reserved accordingly in each affected county fund.

As the assessment appeals for one taxpayer has been resolved for three fiscal years, the impounded taxes of \$2,196,946 (FY 2011/12 \$664,289, FY 2013/14 \$838,424 and FY 2014/15 \$694,233) for affected taxing entities are being released and their related accounts receivable for the County controlled funds is being eliminated. Of the \$2,196,946 impounded, \$350,524 is being refunded to the taxpayer and the remaining \$1,846,422 is being returned to the affected taxing entities.

Of the \$735,780 taxes impounded for all three fiscal years from County controlled funds, \$117,394 is being released to the taxpayer as refunds and the remainder (\$618,386 is being returned to the taxing entities. This action releases the nonspendable fund balance to reflect the elimination of the accounts receivable.
