### THIRD AMENDMENT TO SYSTEM AGREEMENT

between

### **COUNTY OF SANTA BARBARA**

and

### **GE HEALTHCARE**

April 10, 2014

THIS IS THE THIRD AMENDMENT TO SYSTEM AGREEMENT (Third Amendment) dated March 15, 2011, (Contract Number BC-11-083) and as may be amended, (Existing Agreement), made by and between the County of Santa Barbara, a political subdivision of the State of California (COUNTY), and General Electric Company, by and through its GE Healthcare division, a New York corporation (CONTRACTOR).

WHEREAS, the Existing Agreement is effective through March 14, 2016; and

WHEREAS, the parties desire to amend the Existing Agreement to adjust compensation to provide for Change Order Number O52ALA002XCK which shall provide for additional software and licenses to implement base immunization export package (51-75 MD) to the electronic health record (EHR) system as well as support and maintenance services; and

WHEREAS, this Third Amendment incorporates the terms and conditions set forth in the Existing Agreement, except as modified by this Third Amendment;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR hereby agree to amend the Existing Agreement as follows:

- 1. **Definitions.** Capitalized terms used in this Third Amendment, to the extent not otherwise defined herein, shall have the same meanings as in the Existing Agreement.
- 2. Amendments.

The Existing Agreement is amended as follows:

- 1.40 **MAXIMUM AMOUNT.** The Maximum Amount payable under the terms of this Existing Agreement for GE Software Licenses and Maintenance and Support shall be \$1,746,352.51 1,769,547.51 as set forth in Exhibit A. This includes the annual maximum increases for Maintenance and Support for the initial five-year term of the Existing Agreement that expires March 14, 2016.
- 3.3 **MAXIMUM AMOUNT.** The Maximum Amount payable under the terms of this Existing Agreement for GE Software Licenses and Maintenance and Support shall be \$1,746,352.51 1,769,547.51 as set forth in Exhibit A. This includes the annual maximum increases for Maintenance and Support for the initial five-year term of the Existing Agreement that expires March 14, 2016.

The Exhibits are amended as follows:

EXHIBIT B, PAYMENT SCHEDULE, shall incorporate EXHIBIT B-3, BASE IMMUNIZATION CHANGE ORDERS, attached hereto and incorporated herein by reference.

EXHIBIT F, STATEMENT OF WORK, shall incorporate EHHIBIT F-2, Base Immunization Export Package Statement of Work, attached hereto and incorporated herein by reference.

- 3. Ratifications. The terms and provisions set forth in this Third Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Agreement, First Amendment and Second Amendment. The terms and provisions of the Agreement, as expressly modified and superseded by this Third Amendment, are ratified and confirmed and shall continue in full force and effect, and shall continue to be legal, valid, binding and enforceable obligations of the parties.
- 4. Counterparts. This Third Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.

IN WITNESS WHEREOF, the parties have executed this Third Amendment to be effective on the date of execution hereof by the Board of Supervisor's approval of the Third Amendment.

Purpose: Purchase the Base Immunization Export Package software including licensing, installation and maintenance for the existing GE Centricity EMR. The license term for the GE Healthcare software products included in this quotation is perpetual, except for any Computer/Online Based Training (CBT) software or modules which are licensed on an annual basis.

Product Description: The Base Immunization Export Package works with the existing Qvera interface engine installed with the GE application and will allow the Public Health Department to submit immunization data electronically to the State of California Immunization Registry in order to meet Meaningful Use Stage 2 requirements. Licensed software will be shipped or electronically delivered immediately upon receipt of a signed Quotation. Included with the licensed software will be the issuance of the keys that enable the use of the Licensed Software. Installation includes configuration of the software and will be accomplished through remote scheduled sessions. Professional services related to installation shall be invoiced upon the Go-Live Date, which means testing is successfully completed and the Licensed Software is ready for use in a production environment.

Maintenance and Support Services: The initial Term of Maintenance and Support shall commence, and the annual fees shall be invoiced upon the Installation Date and the anniversary of the Installation Date and maintenance and support services shall end the day prior to the anniversary of such date. Services shall continue uninterrupted during period between invoice date and payment. The last date of service will be the day before Installation Date of 2016.
