### Summary Text:

This item is on the agenda in order to approve and authorize the Department of Social Services (DSS) Director, or designee, to receive \$2,000,000.00 in Federal grant funding by signing the Grant Agreement for Federal Award Id. No. MI-28988-16-60-A-6 (Attachment 1). The United States Department of Labor Employment and Training Administration (DOLETA) approved grant funding for the County of Santa Barbara Workforce Development Board under Federal Award Id. No. MI-28988-16-60-A-6, which is a Dislocated Worker National Reserve Demonstration Grant in the amount of \$2,000,000.00 for a project entitled Summer Jobs and Beyond: Career Pathways for Youth (CPY). The period of performance is from May 20, 2016 through June 19, 2018. The fiscal agent for the grant is the County of Santa Barbara Department of Social Services (DSS). The program funded by the grant will be administered by the Santa Barbara County Workforce Development Board (WDB).

## **Background:**

DOLETA awards Federal grant funding for CPY programs to local Workforce Development Boards for the purpose of providing employment-related services to eligible youth who are new entrants to the workforce, including those with limited current or past work experience. These programs do not require cost sharing or matching funds. The \$2,000,000.00 Federal grant that DOLETA awarded to the County of Santa Barbara allows funds to be drawn down on an as needed basis using DOLETA's Payments Management System. The terms of the grant are set forth in Notice of Award signed by the DOLETA approving official and to be signed by the DSS Director or designee (Attachment 1). The program funded by the grant will be administered by the Santa Barbara County Workforce Development Board (WDB).

The project area for the grant is in the City of Santa Maria. This is the only CPY grant DOLETA awarded this year in California. DOLETA awards only 10-11 CPY grants each year and targets highcrime communities. The crime trends in the City of Santa Maria are compelling. During the months preceding the grant application in March 2016 the City of Santa Maria had seen a tremendous increase in homicides among disconnected and gang-affiliated youth ranging from ages 14-24. In the preceding 15 months, there were 19 murders, all youth related, and many involving youth as young as 15 years of age.

During the past couple of years, the City of Santa Maria has experienced some of the highest unemployment in Santa Barbara County, easily eclipsing the county, state and national average. Unemployment as reported by the U.S. Census for youth 16-19 and 20-24 for the City of Santa Maria is currently 36.7%, compared to the DOL reported youth unemployment rate of 20.4%. This in turn has translated into youth engaging in illegal activities. Having programs such as the CPY grant funded program will help reduce both youth unemployment and youth crime.

The project will serve City of Santa Maria low-income participants between the 16-24 years of age who are: (a) in-school youth at risk of dropping out of school as indicated by a school official; (b) out-of-school youth who are school drop outs; or (c) youth who are at-risk, gang-involved or involved in the

juvenile justice system." The program is intended to target those youth not qualifying for existing programs, and will be customized to address the severe violence that is affecting the youth in the City of Santa Maria.

The project will align community based organizations to connect youth participants in the program with paid work experience opportunities and related training. Project activities include:

- Skills and Needs Mapping engaging the business community to address: (a) willingness to hire a youth for the summer; (b) willingness to hire a youth for unsubsidized year-round employment; and (c) skills required in future candidates.
- Youth Recruitment and Case Management providing youth with: (a) quality individualized plans; (b) appropriate supportive services and case management; (c) coordinating referrals to other program elements and partners.
- **Employer Training** Coaching employers to ensure successful transition of youth from academy and other pre-employment training services into the workforce.
- **Parent Engagement** providing classes in parenting and preventing violence.
- **Summer Jobs Academy** providing youth with: (a) healthcare services; (b) mental health care services; (c) substance abuse and gang prevention services; (d) financial literacy training; (e) job readiness training; (f) career exploration; and (g) leadership development.
- Education and Training providing youth with: (a) technical skills training; (b) work experience preparation training; (c) career counseling services (resume preparation, interview skills, information on long-term benefits of postsecondary education and training); and (d) occupational information based on labor market conditions and career pathways connection information.
- Work Experience providing youth with subsidized work experience at minimum wage for up to 300 hours.
- **Employment and Career** Connections providing youth with: (a) job search assistance; (b) career exploration for apprenticeship and pre-apprenticeship programs; (c) labor market information; and (d) career pathways on-ramp connections.

The following services are currently being procured and will result in future purchasing/board contracts; board contracts will be brought to the Board of Supervisors for approval:

- Youth Recruitment and Case Management
- Work Experience Coordination
- Customer Service Certification Training
- Leadership Development
- Work Experience: Employer of Record/Payroll Services
- Education and Training for Out of School Youth (OSY)
- Education and Training for In School Youth (ISY)
- Employment and Career Connection: Job and Career Placement
- Other services as requested by DOLETA and/or partners

## **Performance Measure:**

Performance measures to be reported to DOLETA include the following expected outcomes based on serving a total of 260 youth participants:

- 68% of youth participants placed in either: (a) unsubsidized employment or (b) post-secondary education or training;
- 53.5% of youth participants achieving measurable skill gain;
- 70% of employers participating in the program also participating in the "Skills and Needs Mapping Survey";
- 50% of parents attending the Parent Engagement Workshop;
- 70% of youth participants completing the Summer Jobs Academy/Career Camp; and
- 70% of youth participants placed in subsidized paid work experience.
