WHEREAS, on June 20, 2016, the Department of Behavioral Wellness (Behavioral Wellness) received a grant award letter from the California Health Facilities Financing Authority (CHFFA);

WHEREAS, as a prerequisite to receiving funding, the Board of Supervisors must authorize Behavioral Wellness to accept the grant from CHFFA; and

WHEREAS, the County Board of Supervisors desires to enter the Grant Agreement with CHFFA in order to accept grant funds for the purposes set forth in that Agreement;

NOW, THEREFORE BE IT RESOLVED, that the Board of Supervisors of the County of Santa Barbara authorizes the Director of the County of Santa Barbara Department of Behavioral Wellness to accept the grant funds on behalf of County;

BE IT FURTHER RESOLVED, that the Board of Supervisors of the County of Santa Barbara designates the Director of Behavioral Wellness the right, power, and authority to enter into this Agreement and the other Grant Documents to which it is a party, and to carry out and consummate all transactions contemplated by the Grant Agreement and by the other Grant Documents.
