Recommended Actions:

- a) Authorize the County Purchasing Agent, pursuant to County Code Section 2-39, to use the National Joint Powers Alliance to purchase a backhoe loader from John Deere Construction Retail Sales.
- b) Find that this action is not a "Project" within the meaning of the California Environmental Quality Act, pursuant to 14 CCR 15378 (b)(2), in that it is a continuing administrative activity that will not result in a direct physical change in the environment and approve the filing of a Notice of Exemption on that basis.

Summary Text:

This item is on the agenda in order to allow the Laguna County Sanitation District to purchase a backhoe loader in the amount of \$121,994.43 through the National Joint Powers Alliance (NJPA) from low bidder John Deere Construction Retail Sales.

Background:

The National Joint Powers Alliance (NJPA) is a governmental entity that uses national purchasing power to competitively solicit purchasing contracts pursuant to Uniform Municipal Contracting Law. California Government Code Section 6502 allows public agencies to partner with the NJPA to acquire items such as heavy equipment. The County of Santa Barbara is a member of the NJPA. The purchase of the backhoe loader from John Deere Construction Retail Sales is pursuant to NJPA Cooperative

Contract 032515-JDC and is in the amount of \$121,994.43, which includes a discount of \$78,525.45 (45%) off the base price).

Performance Measure:

The purchase of this backhoe loader replaces the last backhoe loader purchased in 2000, which exceeds the typical useful life of 10 years. In addition, the existing backhoe is expected to become obsolete due to California Air Resources Board regulations.
