Title: Adjust Inter-Departmental transfers, Sources & Uses of Funds for Aviation Support Unit

Budget Action: Increase appropriations of \$290,514 in the Fire Department's Fire Protection District Fund for Salaries and Benefits funded by a release of Restricted Purpose of Fund, Fund Balance. In addition, inter-departmental transfers between Sheriff and Fire will decrease budgeted Other Financing Sources of \$597,307 in

General Fund Sheriff's Department offset by a decrease of appropriations in Other Financing Uses (\$295,000), Salaries and Benefits (\$247,467) and Services

and Supplies (\$54,840).

Justification: The Sheriff's Office and the Fire Department have shared the use and cost of the Aviation Support Unit (ASU) under the authority of a Memorandum of

Understanding (MOU) since 2012. Changes in operational usage and need predicated a change in the MOU and sources of funding of the unit. Before, funding was transferred between the two departments based on estimates. The new MOU spells out amounts by category of shared funding. Before, all employees were managed by the Sheriff's Office. The proposed MOU shifts two staff from the Sheriff's Office to the Fire Department and creates an additional position to enhance operational flight capacity. This revision reverses the Adopted budget for inter-department transfers, adjusts expenditures in both departments to reflect the changes in the proposed MOU, and resets transfer amounts from the Fire Department to the Sheriff in accordance to the new

agreement.
