#### **Recommended Actions:**

That the Board of Supervisors:

Consider an amendment to the 2016 Board of Supervisors' Schedule of Meeting Dates and Locations by changing the locations of the November 1, 2016 and November 8, 2016 meetings.

### **Summary Text:**

In reviewing the 2016 Board meeting schedule during the weekly agenda review process, the Chair considered a request from the Clerk-Recorder-Assessor-Registrar of Voters to consider moving the November 8, 2016 meeting from Santa Maria to Santa Barbara due to the Presidential General Election being held that day. The Joe Centeno Betteravia Government Center Administration Building is an official polling place and space and parking constraints could lead to disruptions in the Board meeting and, alternatively, could discourage voters from participating in the election. To maintain a Santa Maria meeting in the month of November staff recommends holding the November 1, 2016 meeting in Santa Maria. The proposed amendment would schedule the November 1, 2016 meeting for Santa Maria and the November 8, 2016 meeting for Santa Barbara. Staff was directed to place an item on the September 13, 2016 agenda for consideration by the Board.

As such, staff is recommending that the Board of Supervisors amend the schedule of meeting dates and locations and schedule the November 1, 2016 meeting for Santa Maria and the November 8, 2016 meeting for Santa Barbara.
