### PROJECT PURPOSE



- Initiated by the Board of Supervisors
  - Apply to Caltrans for State Scenic Highway Designation of Highway 101 on the Gaviota Coast
- Last, best example of rural coastal Southern California
- Benefits of the Project:
  - increased tourism along the route
  - enhanced community identity and pride in the scenic character of the Gaviota coast


- State Scenic Highway Application
  - by Santa Barbara County
- Highway 101 on the Gaviota Coast



- 21 miles, from City of Goleta to Route 1/Las Cruces
- Connect to existing Scenic Highway
- Highlight and preserve natural and visual resources of Gaviota Coast
  - Policy 4-8 in Coastal Land Use Plan
  - Eligible Scenic Highway in General Plan
  - Action VIS-3 in Draft Gaviota Coast Plan

## STATE SCENIC HIGHWAYS



- 5
- Managed by Caltrans
- □ Goal: preserve & showcase scenic landscapes
- Requirements: natural beauty, agricultural landscapes, minimal structures
- California has 59 designated sections; two in Santa Barbara County
- No new land use policies or regulations


State Scenic Highway Application

Highway 101 on the Gaviota Coast
21 miles from City of Goleta to Route



- 21 miles, from City of Goleta to Route 1/Las Cruces
- Connect to existing Scenic Highway
- Policy Direction in Coastal Land Use Plan, Scenic Highway Element of General Plan, Draft Gaviota Coast Plan
- No new land use policies or regulations
