

County Staff also recommends rejecting the appeal and only approving the emergency seep cans that are necessary to address the on-going seep problem from existing operations.
- 2. Cyclic Steam Injection method has a high well casing failure rate and there is a history of eruptive well failures at the site. The drilling would occur in an area that is already suffering extensive damage from 100 accidental oil seeps to date. The State predicts at least another 225 seeps in the next 25 years if the Project is approved.
- 3. The Project site is one of the most biologically rich locations in Santa Barbara County. The Project's oil seeps would potentially drown the endangered California Tiger Salamanders and destroy some of the rarest and most imperiled plant communities in the world, such as the Southern Bishop Pine forest and the Burton Mesa Chaparral.
