Budget Action: Increase Appropriations of \$14,700 in Sheriff General Fund for Services and Supplies - Professional Services funded by unanticipated revenue from State of California

Justification: The State of California has instituted a grant program to assist local jurisdictions with the removal costs of hazardous material and debris from navigable waterways. In

October 1997, Senate Bill 172 created the Abandoned Watercraft Abatement Fund (AWAF) the predecessor to the SAVE grant to provide funds for the removal and

disposal of abandoned, wrecked and/or dismantled vessels that may cause a hazardous condition in navigable waterways.

For FY2016-17 SAVE has awarded the Sheriff's Office \$14,700 to assist in the cost of vessel removal and disposal efforts.
