That the Board of Supervisors approve the certification of the Santa Barbara County Employees' Retirement System General and Safety Member Elections, and the election of Pancho R. Occiano II to the General Member (Second Member) position, Frederick Tan to the Safety Member (Seventh Member) position and Ryan Sullivan to the Alternate Safety Member position.

Background and Summary:

The Santa Barbara County Board of Retirement consists of nine members and two alternates. Members of the Retirement System elect four members and two alternates, representing General, Safety, and Retired members of the System. The current terms of the General Member, Safety Member and Alternate Safety Member end December 31, 2016. The Santa Barbara County Clerk, Recorder and Assessor, and Registrar of Voters were engaged to conduct the election, and a filing period for nominating petitions was held July 5 through August 9, 2016. The SBCERS staff has verified that the candidates' petitions are sufficient in accordance with the Trustee Elections Policy adopted by the SBCERS Board of Retirement.

The County Elections Official conducted an election by mail from September 7 through September 28, 2016. There were two candidates for the General Member seat and two candidates for the Safety Member seats, and votes were manually tallied by the Elections Division on September 29, 2016. The Official Canvass of the General Member Candidates returns is as follows:
