- b. Determine that the proposed action is not a project and is exempt from the California Environmental Quality Act pursuant to CEQA Guidelines section 15378(b)(2) as an administrative activity.

Summary Text:

This item is before your Board to authorize the Chair to sign a letter (Attachment A) from the Board of Supervisors to the Department of Alcoholic Beverage Control (ABC) in protest of the application for an Alcoholic Beverage License for HIWI Inc., 6555 Pardall Road in Isla Vista. ABC places additional consideration on protest documents approved by legislative bodies. The Third District Supervisor supports the submission of a protest due to this expansion of the number of licenses in Isla Vista.

Background:

Approval of this alcohol license will be detrimental to the public health and safety of Isla Vista residents, and surrounding communities. Expanding access to alcohol increases the risk of underage drinking, drunk driving, and other serious crimes, including sexual assault and burglary. New alcohol

licenses have not been approved in Isla Vista for many years and the census tract indicates that Isla Vista already has an overconcentration of alcohol licenses. Sheriff Bill Brown will also protest Hiwi Inc's application for an Alcoholic Beverage License.
