Title: CSD: Baron Ranch Trail Extension

Budget Action: Increase Appropriations of \$35,000 in CSD, Parks Capital Projects Fund for Capital Assets funded by unanticipated Charges for Services Revenue (\$35,000).

Justification: The total cost of the planning and permitting process for the project is estimated to be \$135,000. \$100,000 was previously appropriated by the Board and upon approval of the Budget Revision, the remaining \$35,000 will be allocated from Quimby Fund 1400 South Coast West for completion of the planning and permitting process.

Amec is currently under contract via purchasing contract with the County of Santa Barbara through December 31, 2016 for planning, environmental document preparation and permit processing for the Baron Ranch Trail Project. The project entails construction of visitor serving facilities including a parking area and vehicle turn-around and bridge improvements. Work by Amec will exceed the \$100,000 purchasing threshold when combined with existing County-wide contracts; therefore, Board approval is required before the services can be authorized to continue past December 2016.
