Title: DA - Increase Appropriations for Human Trafficking Grant Award

Budget Action: Increase Appropriations of \$202,330 in District Attorney's Office General Fund for Salaries & Benefits (\$148,873) and Services & Supplies (\$53,457) funded by

unanticipated revenue from Intergovernmental Revenue-Federal.

Justification: In September of 2016, the DOJ approved funding for the coordinated project proposal and awarded \$1.34 million dollars over a three year grant period to the SB County

District Attorney and Sheriff. This project will provide \$604,390 to the District Attorney's Office and \$740,737 to local law enforcement. The goal was to operationalize the Santa Barbara County Human Trafficking Taskforce through increased funding for victim services and law enforcement resources. Funding for the Sheriff's Office will go toward investigating human trafficking crimes, and the District Attorney's portion will be dedicated to enhancing victim services and designating resources for taskforce

coordination.

The program budget for Fiscal Year 2016 - 2017 is \$202,330. This includes salaries and benefits for a new 1.0 FTE Victim Witness Program Assistant II and on-call overtime costs which total \$148,873. Services and Supplies of \$53,457 are anticipated for developing public service announcements & outreach materials, equipment & office supplies, Rape Crisis Advocacy services pass through, consulting costs, vehicle lease expenses and training.
