#### II. Review of the Draft Jail Rules Booklet

- a. The Jail Rules Committee has completed the draft of the new Jail Rules and Information Booklet. The draft is currently under final review at the command staff level. As agreed upon by the Commanders during the May meeting, they would like our committee to review and provide input prior to finalizing the booklet for printing and distribution.
  - 1. This booklet will be printed in book format at 5.5" X 8.5".
- b. This booklet is provided to all inmates who are processed for housing.
- c. Members of the committee provided input and some minor edits for the final booklet. These recommendations are incorporated in the final version and the Jail Command staff has expressed their appreciation for the thoughtfulness of the information provided by the committee.

#### III. Review of the Jail Orientation pamphlet

- a. The Orientation pamphlet is provided to all inmates who are booked into the facility and is intended as a general guide for those who will only remain in the facility for a short term, generally less than twenty-four (24) hours.
  - 1. This pamphlet will be printed in a double-sided 8.5 "tri-fold document similar to the old jail rules pamphlet that the committee previously reviewed.
- b. Those who are remaining in our custody for a longer period will be issued the new Jail Rules and Information Booklet prior to being transferred to longer-term housing.
- c. The committee provided no edits or recommendations.

# IV. Review of the new ADA Housing Policy and Bunk Assignment Procedures

- a. Both the ADA policy and the bunk assignment procedures have recently been approved and are now in effect facility wide.
- b. The committee was complimentary of the new policy and procedures, indicating that this is a significant step in the right direction.
