WHEREAS, a 2.94 centerline mile section of Lompoc-Casmalia Road from Corral Road to the gate north of Marshallia Ranch Road flooded in the storms of 1995, becoming impassable to vehicular traffic; and

WHEREAS, since 1995, the stretch of Lompoc-Casmalia Road has remained impassable to vehicular traffic and the County has expended no public money on its maintenance; and

WHEREAS, in accordance with Streets and Highways Code § 954, the road sections in Table 1 below are unnecessary highways which the Board of Supervisors may designate as stock trails; and
