WHEREAS, California Vehicle Code Section 21354 and 22507 and the Code of Santa Barbara County, California, Section 23-1 and 23-11, authorize the Board of Supervisors of the County, to designate portions of roads and highways under its jurisdiction as a through highway or a stop intersection, and to restrict the stopping, standing, or parking of vehicles on portions of roads and highways under its jurisdiction; and

WHEREAS, it is in the best interest of public safety that certain portions of County highways in Santa Barbara County be designated as through highways, stop intersections or no stopping, standing, or parking of vehicles, in accordance with said Sections:

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as through highways, stop intersections, or no stopping, standing, or parking zones and that the Director of Public Works of the County of Santa Barbara is hereby authorized and directed to install and maintain appropriate pavement markings and signs at the following locations.

Through Highway (stop all entering traffic)

- Courtney Drive (Mission Hills) between Onstott Road and Burton Mesa Boulevard
- Onstott Road between Courtney Drive (Mission Hills) and Harris Grade Road
- Solomon Road between State Route 1 and Blosser Road

Stop Control

- Stop Morales Street at its intersection with Hubbard Avenue
- Stop Camino Palomera at its intersection with Camino Cerralvo
- Stop Harris Drive at its intersection with Craig Drive
- Stop Onstott Road at its intersection with Courtney Drive (Mission Hills)
- Stop Westminster Lane at its intersection with Wellington Drive
- Stop Macon Court at its intersection with Foxenwood Drive
- Stop Beverly Court at its intersection with Beverly Drive
- Stop Santa Ana Avenue at its intersection with San Simeon Drive

No Stopping, Standing, or Parking Zones

- On the east side of Las Perlas Drive from a point 58' north of the centerline of Traci Drive to a point 62' south of the centerline of Traci Drive
- On the west side of Las Perlas Drive from a point 70' north of the centerline of the driveway for addresses 601-625 to a point 50' south of the centerline of the driveway for addresses 601-625

Establish Stop Controls on Various Roads in the First, Second, Third and Fourth Supervisorial Districts Page 2 of 2

- On the west side of Puente Drive from a point 190' north of the centerline of Vintage Ranch Lane (north) to a point 120' south of the centerline of Vintage Ranch Lane (north)
- On the west side of Puente Drive from the centerline of Vintage Ranch Lane (south) to a point 150' north of the centerline of Vintage Ranch Lane (south)
- On the north side of Aldebaran Avenue from the centerline of Mizar Place to a point 70' east of the centerline of Mizar Place
- On the north side of Rice Ranch Road from the centerline of Esplanada Avenue to a point 122 feet east of the centerline of Esplanada Avenue

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to install appropriate markings and/or signs at said locations as time and resources permit.
