No. 51C-001, New No. 51C-0373); Federal Project BRLSZD-5951(082); County Project No. 862274; Second Supervisorial District for work performed and materials supplied by Granite Construction Company, (a local vendor), P.O. Box 6744, Santa Barbara, CA 93111, in the amount of \$3,111,223.65; and
- b) Find that pursuant to State California Environmental Quality Act Guidelines Section 15162, no substantial changes are proposed, and no new information of substantial importance has come to light regarding environmental effects of the project or of the sufficiency or feasibility of mitigation measures, and therefore the proposed actions are within the scope of the Mitigated Negative Declaration (11NGD-00000-00009) and Mitigation Monitoring Program adopted by the Board upon approval of the project on October 4, 2011, and therefore no new environmental document is required.

Summary Text:

This item is on the agenda to approve the project as constructed and the attached Statement of Final Quantities (SFQ). This project replaced the existing Cathedral Oaks Bridge (No. 51C-001) at San Antonio Creek with a new clearspan bridge (No. 51C-0373) which included widening the structure to include standard lane widths, improve roadway geometrics, and improve access for pedestrians and bicycles. The Director of Public Works accepted this project as complete on May 27, 2016. The project was completed on time and on budget.

Background:

On October 4, 2011, your Board approved the Project, Mitigated Negative Declaration (11NGD-00000-00009) and Mitigation Monitoring Program, pursuant to the California Environmental Quality Act (CEQA), and authorized the Public Work Department to advertise for construction bids. Caltrans had declared the old bridge seismically deficient, requiring the County to retrofit the bridge. County staff found with further analysis reactive aggregate and determined replacement to be a better strategy The Highway Bridge Program (HBP), through Caltrans concurred with the replacement strategy. The new clear span bridge includes standard width lanes and improved pedestrian and bicycle access.
