Supervisor Wolf and Mary,

As a general summary of ERG's compliance status, as shown in the attached document, our petroleum inspectors logged multiple Petroleum Code violations of different kinds in 2011 (21) and 2012 (20), which coincided with ERG's reactivating parts of the Cat Canyon field and changing out and upgrading old/existing equipment. The violations that were documented were generally addressed quickly and satisfactorily by ERG and closed out by Petroleum staff. The number of violations diminished considerably in 2013 (4), 2014 (3) and 2015 (1), as improved field operations and new equipment began to take effect. Since October 2015, no Petroleum Ordinance violations have been documented.

Our inspectors' general sense of ERG as an operator is that they are cooperative, attentive and responsive, and work to stay on top of their operations.

I noticed that the material from the APCD was cc'd to the Clerk of the Board, and I will leave that to you to take care of as you see fit. I will be attending the hearing tomorrow in the south county Board hearing room.
