Code Sections 6600 et seq.) a prospective claimant wishing to receive an allocation from the Local Transportation fund or the State Transit Assistance Fund shall file its claim with the Santa Barbara County Association of Governments;

**NOW, THEREFORE, BE IT RESOLVED,** that the <u>County Public Works</u> <u>Director</u> is authorized to execute and file an appropriate claim and necessary claim amendments pursuant to applicable rules and regulations promulgated hereunder, together with all necessary supporting documents, with the Santa Barbara County Association of Governments for an allocation of TDA funds in FY <u>2017/2018</u>;

**BE IT FURTHER RESOLVED THAT** the authorized claim include \$77,783 for SBCAG's regional transportation planning, <u>\$100,000</u> for County transit and <u>\$114,010</u> for pedestrian and bicycle facilities, <u>\$1,919,825</u> for Santa Maria, Lompoc, Solvang, Guadalupe and Santa Maria Organization of Transportation Helpers , <u>\$428,984</u> for County street and road purposes; and

BE IT FURTHER RESOLVED THAT a copy of this resolution be transmitted to the Santa

Barbara County Association of Governments in conjunction with the filing of the claim.
