Title: Public Health Dept. unanticipated 340B Savings Share revenues and corresponding appropriations.

Budget Action: Increase appropriations of \$481,616 and \$704,857 in the Public Health Care fund for Services & Supplies and Restricted Health Care Programs Fund Balance,

respectively, funded by unanticipated revenue from Charges for Services.

Justification: This budget revision is necessary to increase appropriations by \$481,616, Restricted Fund Balance by \$704,857, and corresponding revenue by \$1,186,473 in the Public

Health Department Fund 0042. This unanticipated revenues are funded by the Cencal Health amendment which allows for a change in the savings share distribution formula. The Public Health Department will now capture 100% of the of 340B savings share effective January 20, 2017. The PHD estimates the new distribution formula will generate an additional \$1,186,473 in revenue in the current fiscal year. The additional appropriation of \$481,616 will cover increased pharmaceutical cost in FY

2016-17 and the \$704,857 will cover cost of operations in FY 2017-18.
