Title: Release Nonspendable Fund Balance for Release of Property Tax Receivables for affected County funds.

Budget Action: Decrease Property Taxes Receivable of \$179,687 in multiple departments and funds release coresponding Nonspendable Fund Balance established by impounded

property taxes due to assessment appeals filed by taxpayers.

Justification: Under previous Board Authorizations (File # 11-00288, 4/12/2011; #12-00470, 6/19/2012; #13-00286, 4/16/2013) the Auditor-Controller impounded selected 2010-11,

2011-12, and 2012-13 disputed property taxes. When impounded, property taxes were recognized as receivables and, due to the nonspendable nature of receivables,

nonspendable fund balance was reserved accordingly in each affected county fund.

Related 2010 assessment appeals cases for fractional ownership aircraft (e.g., NetJets, Bombardier Aerospace, Citation Shares, and Flight Options) totaling \$122,747, and 2010, 2011 and 2012 cases for mobile home parks (e.g., Rancho Goleta Lakeside, Silver Sands Village, and Summerland by the Sea) totaling \$588,337, were resolved. Accordingly, impounded property taxes for affected taxing entities are being released and their related accounts receivable for the County controlled funds is being eliminated. This action releases the nonspendable fund balance to reflect the elimination of the accounts receivable.

The affected departments/funds are: General Revenues/General Fund, Fire/Fire Protection District, Public Works/Flood Control & Zone Funds and the Water Agency Fund.
