Summary Text:

The results of the May 9, 2017 Isla Vista Recreation and Park District Special Mailed Ballot Election was certified on May 25, 2017. Elections Code § 15372 requires the Registrar of Voters to prepare a certified statement of the results of the election and submit it to the governing body within 30 days of the election. An official Certificate of Election (Attachment A), Official Election Summary (Attachment B), and Statement of Votes Cast by Precinct (Attachment C) are attached. The official results are also available on the Clerk, Recorder and Assessor & Registrar of Voters website at <u>www.sbcvote.com</u>.

Election Code § 15400 requires that the governing body shall declare the results of the election for each measure under its jurisdiction.

Elections Code § 15620 allows any voter, within five days following the completion of the canvass, to file a request for recount with the county elections official of the votes cast for candidates for any office, or any measure provided that the office or measure is not voted on statewide. The "completion of the canvass" shall be presumed to be that time when the elections official signs the certified statement of the results of the election. As the signing of the certified statement occurred on May 25, 2017, the written request for a recount must be filed with the elections office no later than 5:00 pm on Tuesday, May 30,
