RE:

Consider recommendations regarding Barton Associates Fiscal Year (FY) 2015-2017 Amendment 1, as follows:

- a) Approve and authorize the Chair to execute an Amendment for Services of Independent Contractor with Barton Associates (not a local vendor), to increase the maximum contract amount for Fiscal Year 2016-2017 by \$800,000.00, to allow for payment for continued locum tenens psychiatry services, for a total contact amount not to exceed \$1,920,000.00 for the period December 9, 2015 through June 30, 2017; and
- b) Determine that the above actions are government fiscal activities or funding mechanisms which do not involve any commitment to any specific project which may result in potentially physical impact on the environment, and are therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA guidelines.

### TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

This First Amendment (hereafter First Amended Contract) to the Agreement for Services of Independent Contractor, <u>BC 17-083</u>, is made by and between the **County of Santa Barbara** (County) and **Barton Associates** (Contractor), for the continued services specified herein.

**Whereas,** Contractor represents that it is specially trained, skilled, experienced, and competent to perform the special services required by County and County desires to retain the services of Contractor pursuant to the terms, covenants, and conditions referenced herein;

**Whereas**, at the request of County, Contractor provides locum tenens temporary physicians who provide psychiatric services at County Mental Health facilities, and County has ongoing needs for psychiatric staff at outpatient facilities;

**Whereas**, County anticipates that Contractor will provide, at the request of County, a greater number of services than originally contemplated by the original Agreement, and will incur expenses beyond the value of this Agreement. So as to compensate Contractor for the additional services to be rendered under the Agreement, this First Amendment adds funds in the amount of \$800,000, for a Total Contract Maximum not to exceed \$1,920,000 through June 30, 2017.

**Whereas**, this First Amended Contract incorporates the terms and conditions set forth in the Agreement approved by the County Board of Supervisors on June 21, 2016, except as modified by this First Amended Contract.

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, County and Contract agree as follows:

- 1. Delete <u>Section 1</u> of <u>Exhibit B</u>, and replace with the following:
  - 1. CONTRACT MAXIMUM. For services to be rendered under this contract, Contract shall be paid at the rate(s) specified in the Schedule of Rates (Exhibit B-1), with a maximum value not to exceed \$420,000 for FY 15-16 and \$1,500,000 for FY 16-17.
- II. Delete Exhibit B-1, Schedule of Rates, and replace with the following:
