Justification: The Department of Behavioral Wellness provides a continuum of mental health and substance use disorder services to Santa Barbara County residents, in part through

contracted providers including Community-Based Organizations (CBOs). Contracts with facilities providing services at various levels of care are key to ensuring that the needs of clients are optimally met. Due to an increased demand for inpatient contracted long-term beds, Behavioral Wellness needs to amend California Psychiatric Transitions. This amendment will be funded by an unanticipated FY 2010-2011 cost settlement payment from the State. Approval of the recommended actions will allow

Behavioral Wellness to continue to provide mandated mental health, substance use, and ancillary services.
