### **Recommended Actions:**

That the Board of Supervisors:

- a) Approve and authorize the Chair to execute the first amendment to an agreement with the California Department of Food and Agriculture (CDFA) to increase reimbursement by \$116,569.04 for the County's Detector Dog Team Program for the period of July 1, 2016 through June 30, 2017 and
- b) Determine that the above action involves government funding mechanisms and/or fiscal activities and is not a project under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines section 15378(b) (4).

#### **Summary Text:**

Approval of this contract amendment will enable the department to be reimbursed for activities that support the Detector Dog Team. The source of the revenue increase is additional funding from the USDA.

#### **Background:**

The purpose for the Detector Dog Team is to enhance current department inspection and surveillance

activities of plant products entering Santa Barbara County via parcel delivery facilities such as UPS, Federal Express, On Trac, and the US Postal Service. The one dog and one handler team works approximately 20 hours a week at the delivery facilities "sniffing" packages while they are sorted into delivery trucks. When the dog detects a package containing any plant material, he will alert the handler by pawing the package. It will then be set aside for inspection. If a pest is found, the package is quarantined and a sample sent to the state laboratory for official identification. Packages containing prohibited pests that pose a threat to the economic or environmental well-being of the State are destroyed. The Board of Supervisors initially approved this program on July 21, 2015. The contract which is proposed for amendment was approved by the Board on May 17, 2016, and initially provided the County with \$29.671.49 in reimbursement from the CDFA. The proposed amendment will increase the reimbursement to the County to operate this program by \$116,569.04.
